Realty Income, The Monthly Dividend Company®, is an S&P 500 company. For 50 years our investors have enjoyed monthly dividends which have steadily increased over time. The monthly dividend is supported by over 5,700 freestanding commercial properties that generate rental revenue from long-term net lease agreements. 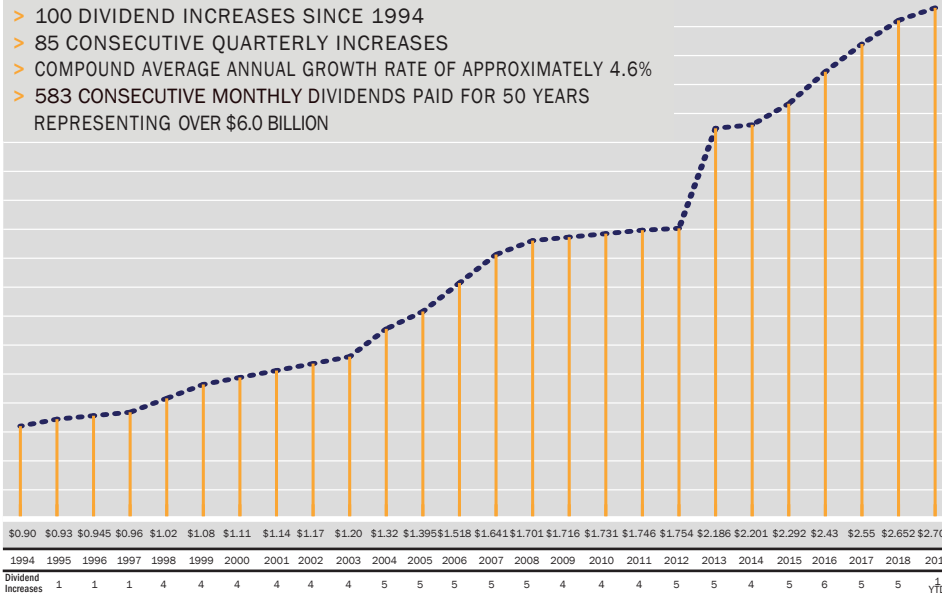

The "Magic" of Rising Dividends Over Time

Increased Income = Increased investment return potential over time. The longer shareholders own Realty Income, the higher their "yield on cost potential," the greater the increase in dividend income, and the greater the potential for enhanced returns.

Example: Investors who purchased Realty Income shares on 12/31/2008 and collect their dividends have received (as of 12/31/2018):

- > 11.5% yield on cost
- > 172% increase in the value of the original investment
- > 56% increase in the amount of annual dividend income
- > 91% of the original investment paid back as dividend income

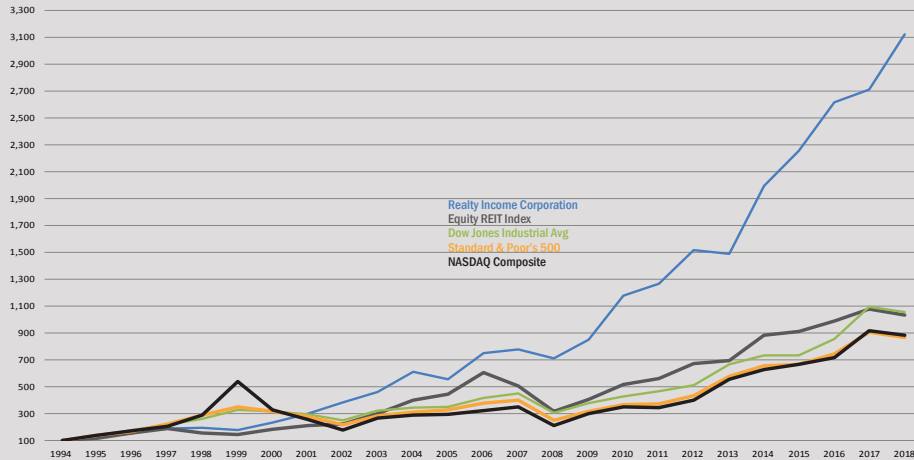
